- Regional review update provided by Brian Rosborough and should be forthcoming later in the fall
- AMO's pre-budget submission to the Province is explained by Brian Rosborough and it will concentrate on municipal finances

- Hospital funding it is noted that the recent announcement for hospitals has been approved ranging from 1% to 1.5% funding for medium and small municipalities totalling 68 million dollars
- Jim Pine has been appointed by the Province to look into the EMS and Modernization funding for hospitals
- Modernization fund Administrative Officer McCabe will send out something to the OSUM members asking them to provide some detail with regards to their funding and the areas that they have spent it on or reserved.
- Recreation grants are discussed with regards to small renos and major capital
- Joint and Several Liability noting that AMO is consulting with the Province in this matter and preparing a consultation paper
- Native Consultation is discussed
- Local Service OPP and it is noted that AMO are reviewing this matter
- Homelessness issue is discussed and concerns are expressed in this area this may be a topic for the Conference in 2020
- Cannabis legislation
